**ALL HUNTS INCLUDE** lodging, food and drinks (light snacks and one prepared dinner meal daily and non-alcoholic beverages), quality stands/blinds/heaters/chairs, and use of ATVs and truck.

**Sportsman is responsible for:** obtaining state and locally required licenses, tags, permits, and if Sportsman was born after 1967, a Sportsman safety course certificate is mandatory; arranging their own airfare to KCI Airport, and any other transportation; arranging for their own bow/firearm and ammo, personal gear, processing/shipping/taxidermy for trophy.

It is mutually understood by the parties that C.K. Outdoor Adventures LLC (CKOA), and anyone working with and for the C.K. Outdoor Adventures LLC (CKOA), will not be held responsible for any injury, accident, loss, damages, weather delays, acts of God, incurred as a result of or during the course of the semi-guided hunt. Any expenses, losses or damages arising from the hunt remain the responsibility of the Sportsman. C.K. Outdoor Adventures LLC (CKOA) reserves the right to halt and/or cancel the hunt.
