Please read carefully before signing. This is a release of liability and waiver of certain legal rights.

In consideration for my being permitted to participate in the activities of **C.K. Outdoor Adventures LLC** (**CKOA**) and be present in stands/blinds, I agree to the following **Waiver and Release**:

I acknowledge that hunting has inherent risks, hazards, and dangers for anyone that cannot be eliminated, particularly in a wilderness environment. I UNDERSTAND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATION:

- 1. Water hazards, including drowning.
- 2. Hiking in rugged and/or hilly country
- 3. Injuries from hunting equipment and other participants; including falls
- 4. Encounters with wildlife, animals, and insects
- 5. Temperature extremes
- 6. Inclement weather conditions and unavailability of immediate medical attention in the wilderness in case of injury

I understand the risks, hazards, and dangers of hunting. I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe I have that good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks.

I AM VOLUNTARILY USING THE SERVICE OF CK Outdoor Adventures (CKOA) WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS, OR DEATH.

Lastly, I, for myself, my heirs, successors, executors, and subordinates, hereby KNOWINGLY AND INTENTIONALLY WAIVE AND RELEASE, INDEMNIFY AND HOLD HARMLESS C.K. OUTDOOR ADVENTURES LLC (CKOA), their directors, officers, agents, employees, and volunteers from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorney fees) which are related to, arise out of, or are in any way connected with my participation in this activity including, but not limited to NEGLIGENCE of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly out of any damage, loss, injury, paralysis, or death to me or may property as a result of my engaging in these activities or the use of these services, animals or equipment, whether such damages, loss, injury, paralysis, or death results from negligence of C.K. Outdoor Adventures LLC (CKOA) or from some other cause. I, for myself, my heirs, my successors, executors, and subordinates, further agree not to sue C.K. Outdoor Adventures LLC (CKOA) in any manner as a result of any injury, paralysis, or death suffered in connection with my use and participation in the activities of C.K.
